**Registration Types and Fees:**

- Registration Fees are broken into three (3) categories:
  - Ages 16 and up (includes t-shirt)
  - Ages 8-15 (includes t-shirt)
  - Ages 7 and under (always free, but will not receive a t-shirt)
- Registration Dates and Fees are as follows:
  - Before March 30<sup>th</sup>, 2012 (you will receive t-shirt and other materials via mail)
    - Ages 16 and up: \$30
    - Ages 8-15: \$20
  - April 1, 2012-April 25, 2012 (you must pick up t-shirt and other materials on-site)
    - Ages 16 and up: \$35
    - Ages 8-15: \$25
  - April 26, 2012-Onsite (you must register and pick up materials on-site)
    - Ages 16 and up: \$40
    - Ages 8-15: \$30

**Event Details:**

- Mutt Strut is held rain or shine
- All attendees of the event, regardless if one walks the track, must pay the registration fee
- The registration fee applies to people, not animals. Attendees may bring as many animals as they can safely handle, properly vaccinated and on a non-retractable leash less than six feet long.

## Mutt Strut 2012 Release Form: READ! YOUR LEGAL RIGHTS ARE AFFECTED.

TO BE READ AND SIGNED BY EACH PERSON BEFORE BEING ISSUED CREDENTIALS FOR ACCESS TO THE PREMISES OF THE INDIANAPOLIS MOTOR SPEEDWAY.

I request Indianapolis Motor Speedway, LLC and its affiliates (collectively, "IMS" to provide me with the credentials which will authorize me to have access to certain premises of the Indianapolis Motor Speedway ("Speedway"), including certain restricted areas. In consideration for the granting of this privilege, I, the undersigned, for myself and my heirs, assigns and personal representatives, do hereby agree to the following conditions:

Conditions:

1. I AGREE that the privileges extended to me Will not be transferred to another and can be revoked at any time for any reason which IMS determines in its sole discretion to be desirable, including but, not limited to, improper attire, misconduct, misuse of any privilege granted to me, or failure to observe IMS rules (including without limitations, failure to observe the stated speed limit for track laps). I UNDERSTAND that false information given to obtain credentials or misuse of assigned credentials (transferring, duplication, etc.) will result in revocation of all credentials. The issuance of current and future credentials shall be in IMS' sole discretion.

2. I understand and agree for myself, my employer and/or each third party I represent that IMS and its successors and assigns, shall have and own, in connection with any race, racing activities, or other event (collectively, "events") held on the premises of the Speedway, the sole and exclusive right to commercially exploit such events including all rights to all photographs, video reproductions, audio reproductions, films or motion pictures, radio or television broadcasts and other reproductions or depictions of any such events or any portion thereof, including without limitation descriptions, pictures, likenesses, images, name and sound of myself alone or with others, through any and all media whether known or hereafter discovered, and to copyright, reproduce, distribute, display, perform, sell, license or otherwise dispose of the same for any purpose whatsoever, including the advertising and exploitation thereof, together with alterations and derivate works each of the above. I also hereby grant to IMS a non-exclusive, perpetual license to use my rights of publicity (or similar) for the purpose of promoting the events and IMS. I agree that I will not reproduce, sell or otherwise use or exploit any photograph, film, video, audio, depiction or reproduction of IMS' premises, trademark, service marks, name, events, or other property, or assist another party in doing any of the foregoing, without IMS' or, when appropriate, other applicable third party's prior written consent.

3. I UNDERSTAND that my presence on the premises of the Speedway can expose me to dangers both from known risk and unanticipated risk. Acknowledging that such risks exist, I assume that risk, including the risk of negligent conduct. I recognize that negligent conduct can cause property damage and personal injury, including serious injury or death. I also recognize that my injuries and/or damages may be caused, increased or compounded by negligent rescue operations or procedures. I hereby release, waive, discharge and covenant not to sue IMS, Indianapolis Motor Speedway Foundation, Inc., Indy Racing League, LLC ("IRL"), Motorsports Safety Technology, LLC ("MST"), and/or Event participants, and their officers, members, owners, successors, assigns, representatives, agents, employees, and affiliates (collectively, "Released Parties") from any and all claims or liability for personal injury or property damage I may suffer while on the premises of the Speedway, including but not limited to, and claims arising out of any condition of the premises of the Speedway or the conduct of any person in connection with the preparation of, supervision for, or conduct of any practice, qualification, race or race-related activity. Additionally, I specifically release the Released Parties, individually and collectively, for their negligence in any form. In signing this release, I FULLY recognize that if I am hurt and/or my property is damaged while on the premises of the speedway, I will have no right to make a claim or file a lawsuit against the released parties even if they or any of them caused my injury or damage by their negligence. The term "Event participants" shall include any person or entity along with their representatives, agents, employees, affiliates, officers, directors, members, owners, successors and assigns that are in any way associated or connected with the race track facility or race event including but not limited to track owners, race promoters, racing associates, sanctioning organizations, officials, track workers, volunteers, entrants, car owners, drivers, pit crew members, safety crew members, medical personnel, sponsors, manufacturers, designers, suppliers, advertisers, inspectors, construction contractors, engineers, architects, insurers and all persons in restricted area.

4. I AGREE to indemnify and hold harmless the Released Parties from all lawsuits, claims, damages, costs and attorneys' fees which arise out of my presence on the premises of the Speedway and/or my violation or my representative's violation of any provision of this Consent and Liability Release including, but not limited to, the transfer of any credential without the written permission of IMS or the filing of a lawsuit barred by this release including unsuccessful contentions that this release is unenforceable. This provision will apply regardless of whether or not the lawsuit, claim, damages, costs and/or attorneys' fees arise out of the negligence of any of the Released Parties. As I am releasing any claim my family, guardian, representative and/or estate might wish to make by reason of my injury or death, this indemnity provision shall specifically apply to such actions on my behalf and/or any such actions resulting from my injury or death.

I understand the nature of the event and I ASSUME ALL RISKS associated with my voluntary participation in this event including, but not limited to, falls, contact with other participants and animals, the effects of the weather, including extreme temperatures and precipitation and traffic. Knowing these facts, I, for myself, heirs, executors, administrators or anyone else who might make a claim on my behalf, COVENANT NOT TO SUE, WAIVE ALL CLAIMS AGAINST, AND FULLY RELEASE AND DISCHARGE the Humane Society of Indianapolis ("HSI"), any and all sponsors affiliated with the 2012 HSI Mutt Strut, Harrison College, the Indianapolis Motor Speedway, LLC, the City of Indianapolis, the Town of Speedway, race participants, race officials, workers, volunteers, and any and all officers, directors, employees and other representatives of the foregoing, and any successors or assigns of the foregoing (collectively, the "Releasees") for ANY AND ALL claims or liability, including without limitation the sole or contributory negligence of any or all the Releasees, whether foreseen or unforeseen, for death, personal injury (whether temporary or permanent), or property damage arising out of, or in the course of, my participation in this event. In addition I grant HSI, event organizers, sponsors and media sponsors permission to use any audio, video or photographs of my participation in this event for HSI's promotional purposes. By signing this waiver I ASSUME ALL RISKS and take full responsibility for any and all additional participants I have registered for the event. Additional participants are held to the same guidelines as stated above in all regards with the signing Releasee taking full responsibility.
